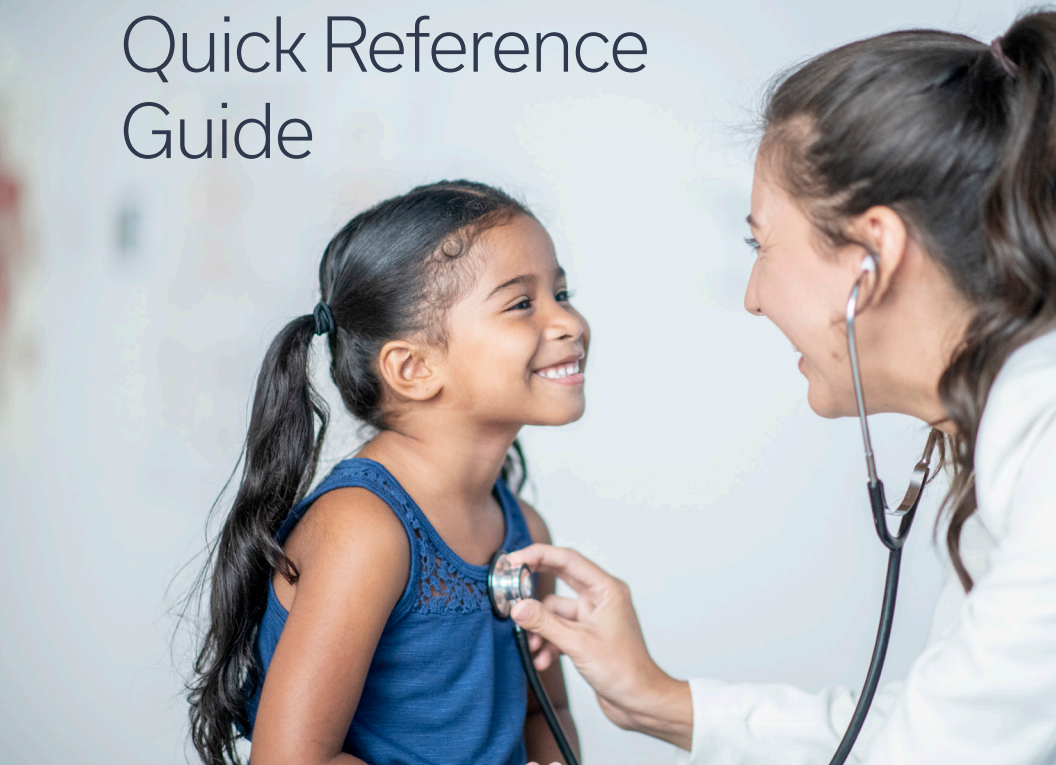

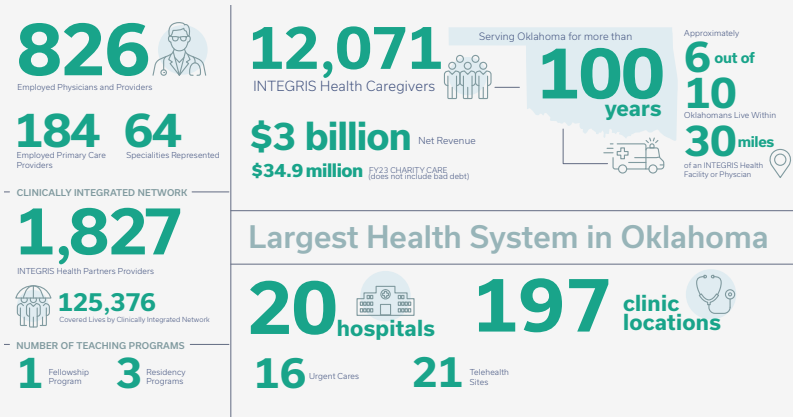


## ABOUT INTEGRIS HEALTH

## ORGANIZATION HISTORY

INTEGRIS Health resulted from a merger in 1995 between Oklahoma Health System and Southwest Medical Center in Oklahoma City. It has since grown into the largest Oklahoma-owned not-for-profit health system in the state, and it is known for innovation and unparalleled quality offering advanced treatment options and specialties found nowhere else in the region. It is also one of the state's largest private employers with hospitals, rehabilitation centers, physician clinics, mental health facilities, hospice and home health agencies throughout the state.

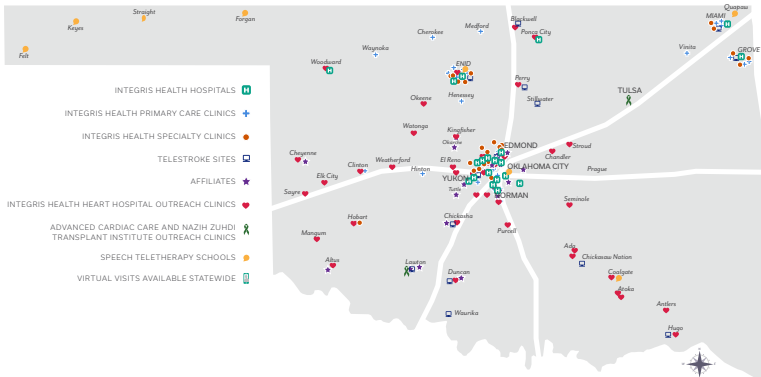
The roots of INTEGRIS Health can be traced all the way to the early beginnings of statehood. INTEGRIS Bass Baptist Health Center, as it's known today in Enid, opened in 1910, INTEGRIS Health Baptist Medical Center opened in 1959 when it began as Baptist Memorial Hospital. In 1994, the Oklahoma Healthcare Corporation merged with Baptist Healthcare of Oklahoma to form a new organization named Oklahoma Health System. One year later, Southwest Medical Center merged with the newly formed system and the organization was renamed INTEGRIS Health. The new organization quickly grew in the mid-'90s as it expanded into a statewide health system through a series of mergers with hospitals across the state. Today, corporate headquarters are located in Oklahoma City. INTEGRIS Health and its affiliated entities are recognized as leaders in providing quality health care to Oklahoma for more than 100 years.
